## MINUTES OF THE ANNUAL GENERAL APPROVED EXTENSION MEETING

Circular 18

Date 7 Sptember 2015

Time 18h00

Venue Christian Family Centre

#### WELCOME ADDRESS BY THE MANAGING AGENT - EON PROPERTY SERVICES

Mr. Sjoerd Lohle (SL) from EON Property welcomed the members present and explained that this is the adjourned meeting of the meeting held on 24 August 2015. In terms of protocol the meeting can only proceed when a quorum is present or can continue with the members present at 18h30.

A special Circular 18 was distributed to members to inform them of the procedures of tonight's meeting, more particular that members that are in arears cannot participate in the meeting.

#### **COMPLETION OF THE ATTENDANCE REGISTER**

Members completed the attendance register and submitted the proxy certificates

#### **CONSTITUTION OF THE MEETING**

Mr. Lohle informed the meeting:

- 1. 97 members were present in proxy and in person
- 2. A quorum was not present but because this is an adjourned meeting the members present formed a quorum and the meeting may proceed

#### **MEMBERS MEETING**

SL noted that the Elisenheim "Proper" members held a meeting on 3 September 2015 where members discussed aspects of the budget and other relevant matters for the meeting of tonight. SL will deal with the issues as the meeting progresses

#### **MATTERS ON THE AGENDA**

#### **Chairman's Report**

It was noted that the Chairman – Mr. Wayne Mc Teer – rendered his apology for not being at the meeting as his annual leave was arranged before it was known that the meeting of 24 August would be adjourned.

## SL informed the meeting:

- The Chairman's report was distributed to all the members
- Questions with regard to matters mentioned in the report will be dealt with
- The issues raised at the meeting on 3 September will be dealt with first
- Other questions will be dealt with thereafter

### Questions and answers were dealt with as follows:

- The Fuel expenses expressed in the financial statements was N\$30,753-00 Why there is an increase in fuel expenses to N\$62,400-00
  - SL informed the meeting:
    - In the previous budget the costs were estimated at N\$120,000-00
    - The Estate Manager Position and workers, although included in the budget for the previous period was not utilized because the Estate Manager position was made redundant at a meeting in 2014
    - The Estate Manager position was reinstated from 1 August 2015
    - The activities for Estate Management will increase and hence the increase and the cost of fuel for the various vehicles
- What is the cost budgeted for Estate Management = N\$336,000-00
  - SL informed the meeting:
    - EON was appointed initially to attend to the administration of the Elisenheim Owners Association
    - The cost for the administration of the estate amounts to N\$292,560-00
    - After numerous complaints from members about the management of the estate the Board of Trustees decided that the position of "The Estate Manager" must be reintroduced from 1 August 2015
    - EON was appointed to attend to the Estate Management
    - Mr. Schalk Kruger (Snr) from EON was appointed by EON to attend to the Estate Management Position
    - Schalk was introduced to the members at the meeting and it was noted that EON circulated three Circulars with more information about the estate management
    - The composition of the costs queried were staff costs
- What is the amount for office rent = N\$42,000-00
  - SL informed the meeting:
    - It is important that the Estate Manager has a presence on the Estate
    - Until such time that EON can procure offices on the estate we have rented the container office on the contractors site on the estate
    - The cost of renting the office constitutes the office rent
- Why the amount in security provision remained the same when the EPDC assumed responsibility of the Perimeter fence at a cost saving of N\$660,000-00

- SL informed the meeting:
  - Security at the Estate remains the No 1 priority for preserving the lifestyle
  - The Trustees thought it appropriate to keep the budget the same as in the previous period and use the surplus to further enhance security on the estate
  - Access control is paramount to achieving security goals
  - Cost for implementing access control will be high and we must make provision
  - Continuous presence on the estate will further enhance security
  - It is envisaged that security on mountain bikes will patrol the area 24/7
  - Proposals are not final but the cost is estimated at N\$56,000-00 per month = annual N\$672,000-00
  - The security committee will finalise the security improvements

The meeting enquired the ability of members to vote and amend the budget as presented by the Trustees of the EOA.

Mr. Schalk Kruger (Jnr.) informed the meeting that the members cannot change the budget and that members should direct all their queries via the Representatives that will be elected tonight for submission to the EOA Board of Trustees for comment and response.

The meeting resolved to follow the process as explained and that the meeting should continue with the election of representatives.

### **Election of Representatives**

SL referred the members to the Circular that dealt with the procedures for the election of representatives:

- Nominations received by the Board of Representatives before the meeting will be announced and the members introduced to the meeting with a short résumé
- The meeting will call for further nominations of members present at the meeting
- Persons nominated will be requested to give a brief résumé to the members present
- Once all the nominated members are introduced we will call for the meeting to start with the voting process
  - O Voting for members will be by a show of hands
  - o If there are more than four nominations:
    - Vote to determine who the elected four members will be

SL informed the meeting that the following nominations were received:

- 1. Mrs. Corine Brink
- 2. Mr. Gerbrand Prinsloo
- 3. Mr. Paulus Shituna
- 4. Mr. Jakobus Lowe
- 5. Prof. Elizabeth Amukugo

Each nominee provided the meeting with a short résumé.

SL informed the meeting:

- In terms of the votes received Mr. Shituna procured the least votes and is eliminated
- From the remaining four nominees members must vote:
  - To elect the two representatives who will serve on the Board of Trustees
  - The remaining two members will serve on the board of representatives

The voting continued whereby members voted by a show of hands to determine the number of votes for each nominee that will be elected to serve on the EOA Board of Trustees. Each member had two votes. In terms of the voting:

- Mr. Gerbrand Prinsloo and Mr. Jakobus Lowe were elected to serve the on the Board of Trustees
- Prof Amukugo and Mrs. Corine Brink were elected to the Board of Representatives.

At the first meeting of Trustees and Representatives the portfolios assigned to the members will be determined

#### **Sub Committee Members**

SL informed the meeting that the sub committees require members to assist with the management of the estate and members should nominate persons to be co-opted onto these committees.

More than one member showed an interest to serve on these committees and it was agreed that the persons nominated will serve on the committees
